CONTAINER YARDS



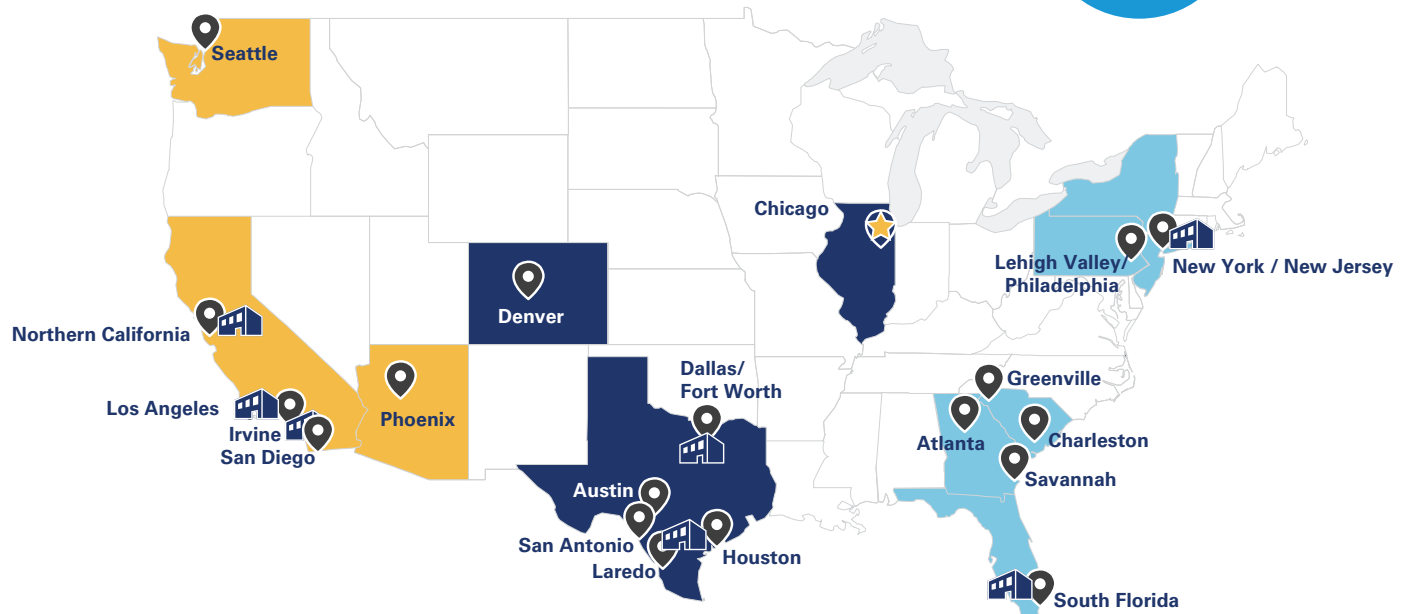
- + Staging and handling facilities for domestic and international containers
